CPDI Conducts Orientation Session on Right to Information for Government Officials and Journalists





Islamabad, 20 July, 2023 – The Center for Peace and Development Initiatives (CPDI) organized a comprehensive orientation session on the Right to Information (RTI) laws for government officials and journalists. He provided a historical and legislative overview of the right to information and freedom of information in the country, highlighting RTI's
